As in previous years, the numerous projects education researchers were involved with in 2023 continued to be wide-ranging, covering such areas as:

This prestigious recognition underscores the calibre of expertise and dedication within our research community. Similarly, the collaborative efforts of Prof Darren Morton and Simon Matthews in co-authoring a section of the Lifestyle Medicine Board Review curriculum for the International Board of Lifestyle Medicine exemplifies our commitment to serving the international academic community.

Prof Darren Morton

In 2023, researchers in the LMHRC attracted over 2 million dollars in research-related funding. Impressively, Prof Brett Mitchell received a 1.5-million-dollar research grant from the Medical Research Future Fund, which is in addition to a 1.5 million dollar grant he received in 2022. These funds will stand the LMHRC in good stead moving forward.

In addition to academic achievements, our researchers actively contribute to addressing pressing public health issues. A Lifestyle Medicine intervention created by Prof Darren Morton that targets mental health is being used in numerous countries to address the mental health crisis. Prof Renee Bittoun's advocacy against vaping and Assoc Prof Joanne Lewis's research on spirituality and nursing exemplify our commitment to addressing contemporary health challenges with evidence-based solutions.

The LMHRC Board also saw some changes in 2023 with the retirement of Dr Paul Rankin. Dr Rankin has made an outstanding contribution to championing Lifestyle Medicine and Health at Avondale University over a long period of time, both researching and teaching. Pam Townend, who leads a high-impact Lifestyle Medicine program in the South Pacific (called "10,000 Toes"), will be replacing Dr Rankin on the LMHRC Board and we look forward to her input and insights.

Overall, the achievements and initiatives outlined in this report underscore the LMHRC's unwavering dedication to advancing knowledge, fostering innovation, and making meaningful contributions to both academia and society at large.

Impact and Community

The LMHRC is dedicated to impactful research and scholarly endeavours in real-world contexts. In 2023, members of the LMHRC engaged in a variety of activities contributing to both the academic and broader communities:

Prof Brett Mitchell's Induction into Nursing Hall of Fame

Recognised for exceptional contributions to Nursing research and practice, Brett was inducted into the Nursing Hall of Fame in July 2023.

Co-authorship for International Board of Lifestyle Medicine

Simon Matthews and Prof Darren Morton co-authored a chapter on "Connectedness and Positive Psychology" for the Lifestyle Medicine Board Review curriculum. The chapter is accompanied by a recorded lecture on the topic, presented by the authors, which is integrated into the training materials.

Conference Presentations

- Prof Brett Mitchell presented four papers at the Australian College for Infection Prevention and Control (ACIPC) conference.
- Dr Mel Renfrew and Prof Darren Morton presented two papers at the American College of Lifestyle Medicine Conference (Denver, Colorado), with one paper receiving the "Excellence in Research" prize. They also presented at the Australasian Society Lifestyle Medicine Conference in Melbourne.
- Prof Daren Morton served as the invited MC for the Australasian Society of Lifestyle Medicine conference and ELIA Wellness conference (Sydney)

Contributions to Public Health

Prof Renee Bittoun's advocacy against vaping included serving on various committees, such as the Federal Government Advisory Committee on Vaping. Renee published an article in *The Conversation* titled "Passive vaping – time we see it like second hand smoke and stand up for the right to clean air", which attracted great interest and readership. Renee has also presented well-received short courses in Smoking Cessation and Tobacco Control throughout 2023.

Podcast Outreach

Prof Brett Mitchell hosts the widely listened to podcast "Infection Control Matters," reaching audiences in over 100 countries.

Research on Spirituality and Nursing

Assoc Prof Joanne Lewis was involved in a paper presented at the International Clinical Education Conference on Spirituality and Nursing and she is actively involved in ongoing research in this field.

Impactful Intervention

The Lift Project, which is a lifestyle medicine intervention that targets mental health and wellbeing created by Prof Darren Morton, has now had over 40,000 registrations from around 40 countries. In 2023, The Lift Project was used in educational, healthcare, workplace and community settings and the roll-out of the intervention serves as a large-scale implementation research project, creating a nexus between community impact and research.

Global Study on Wellbeing

Dr Peter Beamish has been involved in a study commissioned by the General Conference of Seventh-day Adventist Church. The study is a world-wide member initiative and includes measures of wellbeing.

Media Engagement

Several LMHRC members served as content experts in various media channels, notably radio (e.g., ABC National).

Research Grants

In 2023, researchers from the LMHRC obtained over 2 million dollars in funding to support its research activities. Most notably, Prof Brett Mitchell was the recipient of a 1.5-million-dollar competitive research grant from the Medical Research Future Funds—this is in addition to the competitive grant he received in 2022 to the same value (from the National Health and Medical Research Centre). Significant and growing funding has also been obtained through the LMHRC industry partner (Lift Lifestyle Medicine Pty Ltd), which is Directed by Prof Darren Morton.

In addition to the grant funding listed below, the LMHRC strategically invested reserve funding into a variety of initiatives to support the research activities and outputs of the Centre. Most notably, reserve funding was added to external research grant funding obtained by Prof Brett Mitchell to provide two fully funded PhD living allowance scholarships. The recipients of the scholarships were two early career researchers from the School of Nursing and Health, Michelle Chalker and Hannah Kent, who are working on projects under the supervision of Prof Brett Mitchell. The investment will be instrumental in growing the capacity and impact of the LMHRC into the future.

Message from the Director

In 2023, the SSSRC benefited considerably by the appointment of Professor Tracie Mafile'o to a full-time research position at Avondale. She is the principal investigator for three new SSSRC projects commissioned in 2023: (1) The Adventist Families in Australia Study (commissioned on behalf of the Australian Union Conference); (2) GRIT in Ministry Study (commissioned on behalf of the NA Pacific Union); and (3) First Nations Community Development Study (commissioned by ADRA Australia). During this year, she was able to add several significant research projects to her existing research projects that span across Australia, New Zealand, and many of the Island nations of the South Pacific. Much of her time has been spent gaining permissions from the Avondale Human Research Ethics Committees, and in gathering data for these new projects.

Gathering data seems to be a theme of SSSRC-related research in 2023. Two research teams in particular headed by SSSRC Director Rob McIver were able to finalise the collection of data for two major projects they were conducting on behalf of the General Conference of

the Seventh-day Adventist Church. One team, consisting of Professor Rob McIver (lead investigator), Dr Wendy Jackson, Dr Erika Puni, Dr Brendan Pratt, and Dr Stephen Currow, <u>collected survey data</u> from pastors in local Seventh-day Adventist Churches in all 13 Divisions of the world Adventist Church. In total, 12,760 Adventist pastors participated in this study. A preliminary report was considered by the leadership of the General Conference in mid-2023, with a final report available early in 2024 on <u>the ASTR website</u>.

The second team associated with the SSSRC, consisting of Professor Rob McIver (lead investigator), Associate Professor Peter Kilgour, Dr Sherene Hattingh, Dr Wendy Jackson, and Dr Stephen Currow continued collecting data for the General Conference Institutional Workers Survey. By the end of 2023, 13,669 employees of Adventist organizations had participated in this survey, with data collected from all 13 Divisions of the Seventh-day Adventist Church. The final report of this survey will be also available <u>the ASTR website</u> by mid-2024.

Small research grants continue to be an important resource offered by the Scripture, Spirituality and Society Research Centre (SSSRC) at Avondale University. These grants allow significant research to be undertaken in area of society and culture, and one can trace their contribution to many of the publications reported by the SSSRC each year.

Among the publications associated with the research centre in 2023 is the book *Seventh-day Adventist health reform: A crucible of identity tensions* by R. B. Ferret, a work that has already gathered significant academic reviews. The list of publications also includes a further 32 articles submitted by Milton Hook, an adjunct of the SSSRC, to the online *Encyclopedia of Seventh-day Adventists*. We continue to celebrate his significant contribution to this important project.

Impact and Community

The General Conference leadership considered preliminary reports on two surveys, (1) the survey of church pastors in Adventist Churches in all Divisions of the world Seventh-day Adventist Church; (2) the survey of employees of Adventist organizations such as schools, Universities, Media Centres, Hospitals, and publishing houses in many different countries. These reports are being used in formulating the strategic plan of the Seventh-day Adventist Church developed by the General Conference.

Under the auspices of the SSSRC Prof Tracie Mafile'o is co-leading a Pacific elders community study in New Zealand, part of a larger study by "Modifiable Pathways to Sustainable Ageing in Aotearoa" research programme funded in 2023 by the Endeavour Fund, NZ Ministry of Business Innovation and Enterprise. The project overall is providing an evidence base for public policy design, providing key targets for government social policies and service delivery resulting in better life outcomes for older people.

Higher Degree by Research (HDR)

Director's Report

Of our 34 enrolled HDR candidates for 2023, 6 were enrolled in the Master of Philosophy (MPhil) degree and 28 were enrolled in the Doctor of Philosophy PhD degree, including:

- 13 candidates (3 MPhil, 10 PhD) enrolled in the Society & Culture (09) FOE;
- 15 candidates (2 MPhil, 13 PhD) enrolled in Education (07) FOE;
- 4 PhD candidates enrolled in the Health (06) FOE;
- 2 candidates (1 MPhil, 1 PhD) are enrolled in the Management and Commerce/Business (09) FOE

Please find below a collation of the activities facilitated and organised through Research Services in relation to the Higher Degree Research Program in 2023:

Course Implementation and Candidate Experiences

- Revisions to the MPhil and PhD websites. The content and "look and feel" of the MPhil and PhD websites were completely rewritten. Our external consultant, Lesley White, and our Avondale colleague, Angela Jackson, worked closely with our Research Services staff to update the information on these two course sites. Changes were made to ensure the descriptions of the MPhil and PhD degrees are up-to-date, accurate and informative. The style of the two course sites will also be transformed in alignment with the overall Avondale website refresh.
- External consultation was undertaken during the review of HDR-related policies. A number of HDR-related and research-related policies were completely overhauled, and their new versions made available through the online Avondale policy collection in early 2024.
- Research Services are moving to fully manage all HDR enquiries and applications. This action was recommended by the external advisory panel during the most recent MPhil and PhD reaccreditation process. This change will streamline the application process and improve transparency and efficiency.
- To ensure we include the voices, experiences and requests of HDR candidates and supervisors in our Research & Supervisor Training Program, we continue to administer an evaluation survey (once or twice per year). The data gathered during this survey are used to inform the choice of future training events for candidates, supervisors and researchers at Avondale.

Research & Supervision Training Program

- To ensure the training events offered as part of the "Research & Supervisor Training Program" reach as many of our stakeholders as possible, we continue to invite a number of groups, including HDR candidates, HDR supervisors and Avondale's researchers (including community members). This ensures that the "Research & Supervisor Training Program" is offered in a cohesive manner and that the people in all of these groups can avail themselves of the suite of workshops, panel sessions, writing sessions and communities of practice offered as part of this training program.
- During 2022, we were successful in being granted an Academic Strengthening Partnership grant (valued at AU\$120,000) from the Australian Government/Australia High Commission working in partnership with the Government of Papua New Guinea. The project was a collaborative initiative between staff at Pacific Adventist University in PNG and Avondale University titled *Capacity-building novice supervisors: Developing and implementing a co-*

designed supervision training program using a participatory approach. During this project, we co-constructed, facilitated and evaluated three supervisor training workshops for novice HDR supervisors at Avondale University and Pacific Adventist University. The training was targeted specifically at novice research supervisors with 0-4 years' experience. In addition to the valuable collaboration that was forged during this project between Avondale and PAU, the project's outcomes also included:

- The design, development and facilitation of three training workshops for novice research supervisors at Avondale and PAU. These workshops were offered in 2022 and 2023.
- An online Moodle site for supervisors titled "The Supervisor's Little Helper". This site provides resources, advice and guidance for HDR supervisors. The site is currently in the final stages of development and will be launched early in 2024.

- Vladka Henley, An exploration into the factors that influence parents when choosing a faith-based school for their children: An Australian faith-based school system case study
- Don Roy, Morphogenesis of the mission of Adventist education in Australia between 1967 and 2020
- Linda Cloete, An investigation into the use of the Complete Health Improvement Program (CHIP) for reversing Type 2 Diabetes Mellitus




Avondale Academic Press
